WHEREAS, certain solutions are stated in the Memorandum No. 2 of the School Principal (attached herewith);




Clubs Involved	Assigned Area

<b>Girl Scouts of the Philippines</b>	III-Newton, Freshmen classroom surroundings; Library; and BioChem Laboratory (Building D)


